Campaign Information

Distribution will be made once a week and our campaign dates are as follows:

Report Submission: Every Tuesday at 00h00 (GMT +2), late submissions will be ignored
Pay-out Day: Every Friday by 16h00 (GMT +2)
End Date: Last bounty submission will happen on the 02 January 2019 00h00 (GMT +2)

Registration

You will have to register to be part of the bounty programme, become a bounty hunter by signing up at <https://custodi.io>. You will have to pick which bounty campaigns you would like to be a part of.

Bounty Allocation

Custodi will be allocating 5% of our token distribution (70 000 000) to bounty hunters, during pre-sale these tokens will be in the form of a receipt up until ICO actually commences.

General Rules

3. Weekly report submissions will close promptly at 00h00 (GMT +2) every Tuesday for the duration of the campaign.
4. We will only look at one submission of yours a week. Make your first one good as this is the one we will be auditing.
5. Bounty will only be paid in FULL Tokens rounded down to the nearest whole number
6. Custodi reserves the right to ban / remove bounty hunter from all campaigns should we believe that you are not performing honestly and in good manner.
7. Spamming in forums will not be tolerated!

8. Cheating or an attempt to cheat will be dealt with in the most severe of manners.
9. Custodi reserves the right to stop the bounty at any time
10. Custodi reserves the right to add new bounty campaigns at any time
11. Custodi reserves the right to extend bounty campaigns and change the terms of a campaign at any time.
12. The terms and conditions of this agreement can be amended without notice.

YouTube Campaign Terms and Conditions

The following rules will apply in order to qualify for earning bounty from YouTube videos

1. You must be registered as a bounty hunter on <https://custodi.io>
2. You must have submitted a link to your YouTube channel under your Custodi Profile
3. You must subscribe to the Custodi YouTube Channel
4. You must have a minimum of 100 Subscribers
5. Video content must be original, you must not use copyright material.
 - a. You should broadcast the video in the language of your followers
 - b. Video should be a min length of 1 minute
 - c. You should have a link back to the Custodi site
